The RANZCP supports the use of the hierarchy and relies on occupation level listings to help plan for our future workforce needs. Consistent and contemporary occupation classifications is key to understand the work conducted by psychiatrists and provides valuable data about our workforce.

As part of the review of ANZSCO listings, the RANZCP strongly supports that the Specialisations section of Occupation 'Psychiatrist' be updated to reflect contemporary specialist areas in psychiatry. This would align the occupation listing with the RANZCP listing of specialist areas.

Specialist areas in psychiatry:

- Addiction psychiatry
- Child and adolescent psychiatry
- Consultation-liaison psychiatry
- Forensic psychiatry
- Neuropsychiatry
- Old age psychiatry
- Perinatal and infant psychiatry
- Psychiatry of intellectual and developmental disabilities
- Psychiatric psychotherapy

Psychiatry is a broad field with a variety of subspecialties addressing the needs of patients throughout all the stages of life, from childhood and adolescence into adulthood and old age. The RANZCP would be limited in its use of the proposed ANZSCO occupation listings, specifically in identifying specialisation-specific workforce needs.
