TERMS & CONDITIONS

1. Receipt of a signed booking form confirms your intention to support/exhibit.
2. Confirmation is subject to approval by The Royal Australian and New Zealand College of Psychiatrists (RANZCP).
3. Payment must be made within 30 days of invoice, with all payments finalised at least 14 days prior to the event.
4. Withdrawal – if the Supporter/Exhibitor withdraws their commitment they will be liable for the following payments in accordance with the below:
 - a. 3 months or more to the first day of the conference – 75% refund on support and exhibition amount
 - b. 1–3 months prior to the first day of the conference – 50% refund on support and exhibition amount
 - c. Less than 1 month prior to the first day of the conference – No refund on support and exhibition amount
5. All cancellations must be made in writing to events@ranzcp.org
