

Substantial Comparability Pathway

Modified Case based Discussion assessment – Patient information sheet and consent form



The Royal Australian and New Zealand College of Psychiatrists (RANZCP) assess overseas trained specialist psychiatrists wanting to work in Australia/New Zealand using Case based Discussions.

A Case based Discussion uses real patients that the psychiatrist is treating, enabling a quality of assessment that reflects real clinical practice.

In order to be assessed via a Case based Discussion your psychiatrist is required to submit three patient summaries for assessment. An RANZCP Assessor (a senior psychiatrist who is trained in this type of assessment), will assess your psychiatrist via a videoconference Case based Discussion. The RANZCP Assessor will read the case files of the three patients chosen by your psychiatrist and select one for further discussion for the purpose of the assessment. The discussion is based on the case file and you will not need to attend or speak to the Assessor.

On some occasions there may be an Assessor in-training observing the Case based Discussion. This person is also a psychiatrist and a member of the RANZCP and although will not be participating in the assessment, will be privy to the case file information.

The information available to the Assessor and Observer will remain confidential and will only be used for the purpose of conducting the modified Case based Discussion assessment using videoconferencing. Your privacy is a core value of the RANZCP and psychiatrists.

The College values your agreement to assist with this process and requires your written consent to allow the assessor read to your file. The consent form is included in this document.

Substantial Comparability Pathway

It is the Substantial Comparability candidate's responsibility for safe keeping of this form.
