

## Stage 3 EPAs

Fellowship (FELL) EPAs can be attained in any area of practice rotation. Area of practice (AOP) EPAs can be attained in the relevant area of practice only (e.g. trainees are eligible to attain forensic AOP EPAs in forensic psychiatry rotations only).
